ALBANIA WAS SERIOUSLY FLAWED. SOME OBSERVERS WITNESSED FEW OR NO IRREGULARITIES; OTHERS FOUND NOTHING ACCEPTABLE WITH ANY ASPECT OF THE PROCESS. IRI, THE OSCE/ODIHR OBSERVER MISSION, THE OSCE PARLIAMENTARY ASSEMBLY, THE DOMESTIC OBSERVER ORGANIZATION "SOCIETY FOR DEMOCRATIC CULTURE" HAVE ALL RELEASED STATEMENTS. WE UNDERSTAND NDI PLANS NONE, ALTHOUGH WE HAVE DISCUSSED THEIR VIEWS. CONSIDERING ALL OF THESE, THE EMBASSY OBSERVATION EFFORT'S VIEWS COME DOWN APPROXIMATELY IN THE MIDDLE OF ALL THESE GROUPS. ROUGHLY STATED IT IS THAT, WITH CERTAIN NOTABLE AND IMPORTANT EXCEPTIONS, ESPECIALLY IN CERTAIN AREAS, AND ACKNOWLEDGING A LARGE AND TROUBLESOME VOLUME OF TECHNICAL PROBLEMS, THE PROCESS OF BALLOTING DURING THE DAY WENT REASONABLY WELL. MANY MORE SERIOUS IRREGULARITIES WERE NOTED DURING THE COUNTING PHASE; HOWEVER, IT IS VERY DIFFICULT TO CONCLUSIVELY EVALUATE THE COUNTING PHASE, SINCE THE OPPOSITION REPRESENTATIVES PULLED OUT OF THE CONTEST. A FEW HAD OBSERVED ELECTIONS BEFORE. EACH TEAM HAD A FLUENT ALBANIAN SPEAKER OR AN INTERPRETER ALONG. THREE OF THESE TEAMS DID NOT OBSERVE THE VOTE COUNT PHASE OF THE ELECTION.

(C) IT MUST BE NOTED THAT EMBASSY TEAMS ATTEMPTED TO INVESTIGATE REPORTS OF SERIOUS IRREGULARITIES AS THEY WERE RECEIVED FROM OPPOSITION POLITICAL PARTIES THROUGHOUT THE DAY AND FOUND ALL OF THEM EITHER ENTIRELY UNFOUNDED OR EXAGGERATED. WE INVESTIGATED 7 CASES WHERE IT WAS ALLEGED THAT AN OPPOSITION VOTING CENTER COMMISSIONER HAD BEEN ARBITRARILY REMOVED. ALLEGATION IN MOST CASES WAS THAT S/HE HAD BEEN REMOVED BY THE POLICE AT THE INSISTENCE OF THE COMMISSION CHAIRMAN (ALMOST ALWAYS A PD PERSON). IN FIVE OF THESE CASES THE ALLEGATION WAS ENTIRELY FALSE. IN TWO CASES OPPOSITION MEMBERS HAD BEEN REMOVED BY A VOTE IN THE COMMISSION FOR VARIOUS INFRACTIONS.

(U) IRI RELEASED A PRELIMINARY STATEMENT MAY 30, WHICH CONCLUDED THAT "WHILE NOT WIDESPREAD, OBSERVED VOTING IRREGULARITIES RAISE SERIOUS QUESTIONS ABOUT THE CONDUCT AND INTEGRITY OF A NUMBER OF ALBANIA'S 1996 PARLIAMENTARY CONTESTS." THE IRI STATEMENT ENUMERATES PRE-ELECTION PROBLEMS, INCLUDING HARASSMENT OF OPPOSITION MEMBERS, RESTRICTIONS ON OPPOSITION RALLIES, POLICE PARTISANSHIP, AND ELECTORAL ORGANIZATIONAL PROBLEMS. VOTING PROCESS ITSELF, IRI OUTLINED VARIOUS PROCEDURAL INCONSISTENCIES AND NOTED AN UNEVEN APPLICATION OF THE ELECTORAL LAW. IN THE VOTE TABULATION PROCESS, THE STATEMENT NOTES A HIGH NUMBER OF INVALID BALLOTS, AND SPORADIC REPORTS OF REMARKING OF BALLOTS AND REPORTING OF INACCURATE RESULTS. THE STATEMENT ALSO CRITICIZES OPPOSITION PARTIES FOR WITHDRAWING PRIOR TO THE VOTE COUNTING PHASE.

SDC'S STATEMENT

13. (U) IN A MAY 30 DECLARATION, THE ALBANIAN CIVIC NGO "SOCIETY FOR DEMOCRATIC CULTURE" (SDC) NOTED PROBLEMS IT HAD ACCREDITING OBSERVERS IN SEVERAL ELECTION ZONES, THE INABILITY OF OPPOSITION MEMBERS OF MANY VOTING COMMISSIONS TO FULLY OBSERVE VOTING PROCEDURES, AND AN INSUFFICIENT NUMBER OF VOTING PROTOCOLS.
